THE BDO Southern Lakes & Central Otago Accounting Scholarship has been established to provide financial assistance to students of Whakatipu High School to enable them to attend a University in New Zealand and study towards a career in Accounting.

We are interested in encouraging any student from Whakatipu High School into an accounting career. We can assist you by providing financial aid towards your studies through the scholarship award and by gaining work experience as an intern during university holidays.

# **GUIDELINES AND CRITERIA**

To be eligible for the BDO Southern Lakes & Central Otago Scholarship a student must be:

- A permanent resident or citizen of New Zealand.
- Planning to commence their first year of tertiary level study in accounting at a New Zealand University.
- Currently in Year 13 (see notes below).
- Primarily residing in the Queenstown region and are currently studying at Whakatipu High School.
- Students awarded "Discretionary Entrance" to a tertiary institution (or planning to apply for Discretionary Entrance during Year 12), are eligible to apply in Year 12. However, if a scholarship is awarded, but Discretionary Entrance is denied, then the scholarship would be cancelled, and the student will need to apply again in Year 13.
- The scholarship is for the first year of tertiary study only and may be extended for subsequent years at the discretion of BDO Southern Lakes & Central Otago.
- Eligibility restrictions international fee-paying students, those currently on a gap year, those who have already undertaken full or part-time study at a tertiary institution, and those who have been convicted of a criminal offence (being an offence that had a maximum penalty of imprisonment as a possible outcome) are ineligible to apply.
- BDO Southern Lakes & Central Otago may offer holiday work to scholarship recipients.
   There is an expectation that students will have the ability to work in Queenstown for these placements.

## Value of scholarship

The successful student shall receive \$2,500 for every year of full-time tertiary study towards a Bachelor of Commerce with a major in Accounting at a New Zealand University.

## Closing date

Eligible students must submit their competed applications by 5pm on the 27th October 2023

## Selection of scholarship

Selection shall be undertaken by the management team of BDO Southern Lakes & Central Otago.

### Notification of award

BDO Southern Lakes & Central Otago will formally notify the successful applicant and unsuccessful applicant/s by 5pm on the 10<sup>th</sup> November 2023

## Payment and use of scholarship

BDO Southern Lakes & Central Otago will make payment of the scholarship before commencement of the academic year, upon receipt of the official scholarship uplift paperwork and supporting evidence.

The Scholarship can be used towards course fees, course or educational resources, accommodation or basic living expenses.

# Cancellation of scholarship

If for whatever reason a student is awarded a scholarship, however, is unable to accept it, BDO Southern Lakes & Central Otago must be advised by 13th December 2023. BDO Southern Lakes & Central Otago will then be responsible for re-allocating that scholarship.

BDO Southern Lakes & Central Otago reserves the right to cancel a Scholarship if a recipient withdraws from the approved course of study during their first year (period of the scholarship) or if BDO Directors determine that the recipient has behaved in a manner likely to bring BDO or the BDO Southern Lakes & Central Otago Tertiary Education Scholarship Programme into disrepute. Scholarship recipients MUST also advise BDO Southern Lakes & Central Otago immediately if they withdraw from a course of study during their first year.
