Hopkins Enterprises Limited (In Liquidation) ("the Company") was placed into liquidation by special resolution of the shareholders on the 30th day of June 2020 at 9:00 am. Paul Thomas Manning and Kenneth Peter Brown, both Chartered Accountants and Accredited Insolvency Practitioners of Tauranga, were appointed as Joint and Several Liquidators of the company.

Please note that the Directors have signed a solvency certificate prior to the appointment of the Liquidators.

Following the sale of the Company's business and assets, the Company was no longer required and the Shareholder resolved to liquidate the Company.
