1. Introduction

ST Enterprises Limited (formerly Phoenix Commercial Cleaners Limited) (In Liquidation) ("the Company") was placed into liquidation by special resolution of the shareholders on the 23rd day of June 2016. Kenneth Peter Brown and Thomas Lee Rodewald, both Chartered Accountants of Tauranga were appointed as Joint and Several Liquidators of the company.

We set out below our six monthly report on the state of affairs of the above named company as required by section 255 (2)(d) of the Companies Act 1993.

A settlement was reached with the defendant whereby the sum of \$20,000 is to be paid in two instalments of \$10,000 each, on 22 July and 22 August 2019. The defendant has failed to pay these instalment and debt collection proceedings were considered. However, as the defendant has declared bankruptcy and there are no funds it was decided not to proceed.
