#### 1. Introduction

TMP Quality Fixing Limited (“the company”) was put into Liquidation by order of the High Court at Auckland on 12 March 2008 at 10.29am. Thomas Lee Rodewald and Robert James Neilson, Chartered Accountants of Tauranga, were appointed Joint and Several Liquidators of the above named Company. Thomas Lee Rodewald resigned as Joint Liquidator and has been replaced by Paul Thomas Manning as at the 15 March 2012. Robert James Neilson is deceased as of 25 December 2013.

We set out below our six monthly report on the state of affairs of the above named company as required by section 255 (2)(d) of the Companies Act 1993.

**4. Estimated Date of Completion of Liquidation and Notice As To Further Reports**


We expect the liquidation to be completed within the next six month reporting period. A final report will be issued at the conclusion.
