Liquidators' Second Report to Creditors and Shareholders

#### 1. Introduction

Compass Homes (Auckland South) Limited (In Liquidation) ("the Company") was placed into liquidation by special resolution of the shareholders on the 7th day of December 2020 at 10:22 am. Kenneth Peter Brown and Paul Thomas Manning, both Chartered Accountants and Licenced Insolvency Practitioners of Tauranga, were appointed as Joint and Several Liquidators of the company.

In accordance with section 255 (2)(d) of the Companies Act 1993 ("the Act") we are obliged to report to all creditors and shareholders on the conduct of the liquidation during the preceding six month period.

This report should be read in conjunction with our previous report pursuant to section 255 (2)(c) of the Act.

#### 2. Restrictions

This report is not intended for general circulation, nor is it to be reproduced or used for any purpose other than that outlined above without our written permission in each specific instance.

# 3. Conduct of the liquidation within the reporting period

#### 3.1 Asset Realisations

### Plant & Equipment

All available plant and equipment has been disposed of.

#### Debtors

There were no Company debtor funds to collect. However there have been funds received for a building project, initially of the Company's, that was completed by Compass Homes Limited.

#### 3.2 Schedule of Receipts and Payments

#### 3.3 Creditors Claims

#### **Secured Creditors**

AJ Electrical Services Limited - no funds owed Bridgestone New Zealand Limited - PPSR discharged Carters Building Supplies Limited - no funds owed Placemakers - no funds owed

#### **Preferential Creditors**

Inland Revenue has a preferential debt of \$58,960.69.

Compass Homes Limited has a claim of \$309,826.71, preferential pursuant to Clause 1(1)(e), 7<sup>th</sup> Schedule of the Companies Act 1993.



#### **Unsecured Creditors**

Amounts claimed from unsecured creditors totals \$357,693.47.

## 4. Further proposals for completing the liquidation

The Liquidators propose to take the following further actions:

- Obtain legal advice regarding potential voidable transactions;
- continue a review the actions of pre-liquidation Management, Directors, Officers and Advisers of the Company and any potential claims;
- distribute available funds (if any) to preferential and unsecured creditors;
- · assessing other areas of potential recovery; and
- comply with our statutory obligations.

The Liquidators will consider further actions subsequent to additional information regarding the Company's affairs that comes to the Liquidators' attention. Further actions will be subject to the availability of funding and an assessment of the benefits of pursuing recoveries.

## 5. Estimated date of completion

It is not practical to estimate the date of the completion of the liquidation at this stage. Our subsequent reports to creditors and shareholders will, when appropriate, advise of an estimated completion date.
