## Baycom Construction NZ Limited (In Liquidation) Liquidators' Sixth Report

5 December 2018

#### 1. Introduction

Baycom Construction NZ Limited (In Liquidation) ("the Company") was placed into liquidation by special resolution of the shareholders on the 30th day of May 2016. Paul Raymond Clark and Kenneth Peter Brown, both CAANZ Accredited Insolvency Practitioners, of Tauranga were appointed as Joint and Several Liquidators of the company.

Paul Raymond Clark resigned as Liquidator on 7 July 2017 and was replaced by Paul Thomas Manning, Chartered Accountant of Tauranga on the same date.

We set out below our six monthly report on the state of affairs of the above named company as required by section 255 (2)(d) of the Companies Act 1993.

BDO New Zealand Ltd, a New Zealand limited liability company, is a member of BDO International Limited, a UK company limited by guarantee, and forms part of the international BDO network of independent member firms. BDO New Zealand is a national association of independent member firms which operate . as separate legal entities.

### 3. Conduct of the Liquidation

The Liquidators have resolved the issue involving investigations into the Company's affairs with a major creditor. No further action is required. As a result the Liquidators have made a partial distribution to a secured creditor and intend making a further payment before year end.

In addition a teleconference with the Court was held on 4 December 2018 where the Court was advised there will be no dividend available for unsecured creditors. Following that advice the hearing was adjourned until February 2019, but it is likely a Notice of Discontinuance will be filed before then.

As previously advised, the Company was named in June 2015 as the twenty-fourth, fourth party in a statement of claim alleging the Company was to complete and project manage certain school building works. The Liquidators have elected to take no steps in this proceeding. A second proceeding filed in June 2017 lists the Company as the twenty-fourth third party claiming the Company breached its duty by failing to exercise due skill and care, in that a school building is said to suffer a cladding system defect. The Liquidators are also taking no steps in this proceeding.

## 4. Estimated Date of Completion of Liquidation and Notice As To Further Reports

Due to the level of Secured debt unable to be paid in full there will not be any funds available for distribution to unsecured creditors therefore the Liquidators anticipate completing the liquidation within the next six month reporting period. A final report will be issued when the liquidation is complete.
