DSN Limited (In Liquidation) Liquidators' Ninth Report

30 April 2018

1. Introduction

DSN Limited (In Liquidation) ("the Company") was placed into liquidation by special resolution of the shareholders on the 10th day of April 2014. Kenneth Peter Brown and Paul Thomas Manning, both Chartered Accountants of Tauranga were appointed as Joint and Several Liquidators of the company.

We set out below our six monthly report on the state of affairs of the above named company as required by section 255 (2)(d) of the Companies Act 1993.

3. Conduct of the Liquidation

As previously advised, the Liquidators received some payments after the date of liquidation from customers who had not cancelled their automatic payments. Those funds were not therefore pre liquidation funds and needed to be returned to the customers. The Liquidators have distributed funds to customers that have returned confirmation of bank accounts, although the process has been very slow. Eventually the Liquidators may need to forward any unclaimed refunds to Unclaimed Money at the Inland Revenue Department.

The Liquidators have located the Director by engaging the services of a debt collection company, they are pursuing the Director for an outstanding debt.
