# Grow Kiwi Limited (In Liquidation) Liquidators' Fourth Report

26 November 2018

### 1. Introduction

Grow Kiwi Limited (In Liquidation) ("the Company") was placed into liquidation by special resolution of the shareholders on the 26<sup>th</sup> day of May 2017. Kenneth Peter Brown and Paul Raymond Clark, both Accredited Insolvency Practitioners of Tauranga were appointed as Joint and Several Liquidators of the company.

Paul Raymond Clark resigned as Liquidator on 7 July 2017 and was replaced by Paul Thomas Manning, Chartered Accountant of Tauranga on the same date.

We set out below our six monthly report on the state of affairs of the above named company as required by section 255 (2)(d) of the Companies Act 1993.

Completion is dependent on receiving the settlement amount. We anticipate the liquidation will be completed within the next six monthly reporting period. If there is a hold up for any reason, further reports will be issued six monthly. A final report will be issued at the conclusion of the liquidation.
