- e) That the person believes that there exists, and intends to pursue a right of action on behalf of the company under part IX of this Act; or
- f) That, for any other reason, it would not be just and equitable to remove the company from the New Zealand register.

Report on the conduct of the Liquidation

1. Comments on Asset Realisation

This company ceased to trade several years ago prior to Liquidation. Therefore had no debtors or assets. A creditor successfully petitioned to liquidate the company following a Court judgement in their favour. The Liquidators pursued the shareholders and obtained a legal settlement which enabled a dividend to the creditor.
